1/030321 Apologies and approvals of absence

Cllrs Sam Barrell and Will Caston Cook had sent their apologies and their absence was approved.

2/030321 Declarations of Interest and Requests for Dispensation

Cllr Caston declared an interest in planning applications DC/21/00060 and 05895, referred to in Item 14 on the Agenda. He will leave the room during that discussion, passing the chair to Cllr Wright. Cllr Caston Cook also chose to absent himself during discussion of those matters on the Agenda, although he has no pecuniary interest in the applications.

DC/21/00548 | Notification of Works to Trees in a Preservation Order - T1 (Holm Oak) - Reduce crown to reduce load on partially decayed stem by approx 3m in height north 2-3m east 1-2m south 3-4m and west 5-6m. Again the Parish Council will await a written approach before considering a contribution.
