SPC1/050122 - PUBLIC FORUM

There were no members of the public present.

SPC2/050122 - APOLOGIES OF ABSENCE AND APPROVALS

Apologies had been received from Cllr Caston-Cook which was approved. Apologies had also been received from County Cllr Oakes and District Cllr Field who due to the current situation with Covid-19 were offered to not attend should they refer not to.

SPC3/050122 - DECLARATIONS OF INTEREST

None had been received.

SPC4/050122 - APPLICATIONS FOR DISPENSATION

None had been received.

SPC5/050122 - APPROVAL OF THE MINUTES OF THE MEETING HELD ON 1ST DECEMBER 2021

It was AGREED: That the Minute of the meeting held on 1st December 2021 be approved and signed

by the Chairman.

SPC6/050122 - COUNTY COUNCILLOR'S REPORT

Cllr Oakes' report had been circulated prior to the meeting and would be published on the village website.

Cllr Caston reported that he had spoken with Cllr Oakes who had informed him that she would look into improving the mirror opposite the Duke of Marlborough Pub following a complaint by a resident in relation to the speed of vehicles through the village which made the junction with the main road a difficult one to use.

He also reported that Cllr Oakes had spoken of a new County Council initiative, 'Reclaim the Rain' which would concentrate on flooding and how to stop it from happening. She had said that Somersham had been one of the villages that had been chosen as part of the initiative. Cllr Oakes would circulate more information in due course.

SPC7/050122 - DISTRICT COUNCILLOR'S REPORT

Cllr Field was not present at the meeting and a report had not been received.

Cllr Caston reported that he had spoken with Cllr Field who had informed him that the District Council's Budget would be coming up in February which he would report on at the Parish Council's February meeting.

SPC8/050122 - CLERK'S REPORT AND FINANCIAL MATTERS

a) TO RECEIVE THE CLERK'S REPORT

The Clerk had nothing to report in addition to what was already on the Agenda.

b) ICT SUPPORT

The Clerk reported that following her recent resignation from Creeting St Peter Parish Council, the Chairman had asked about the Parish Council's share in the laptop and printer (both of which were under 18 months old) used by the Clerk for her various Parish Councils.
