#### SPC54/24/25 - COUNTY COUNCILLOR'S REPORT

Cllr Oakes' report was circulated prior to the meeting and would be published on the village website.

Cllr Oakes reported that the County Council had submitted a letter which stated their strong objection to the proposed Pylon project asking for off shore or underground options to be looked at. She explained that the National Grid had wanted the project in place by 2030 but it was felt that the more likely date would be 2034. It had been confirmed that by 2034 the cost of the pylons would equal that to the underground option so National Grid's explanation that pylons were less expensive that would then not be the case.
